All banks registered under the Cooperative Societies Act, 1912 are considered cooperative banks. These are banks run by an elected managing committee with



provisions of members' rights and a set of "communally developed and approved bylaws and amendments".

The MTSS scheme is used in order to send inward remittances to India from foreign countries. No outward remittance is allowed under the MTSS Scheme. A maximum of Rs 50000 can be remitted inward as per the provisions of this scheme. A maximum of 30 transactions is allowed per the calendar year in this scheme.

5) Answer: A)

Wholesale Banking refers to the banking activities that mainly focus on institutional customers rather than individual customers. Brick and Mortar Banking is known as the conventional type of banking through the branches. Virtual Banking is defined as a type of banking in which the customers do not require to go to the branches of banks to make transactions. Off-shore Banking is related to the deposit of funds in a country other than the country of residence of the depositor and it is primarily in a low tax jurisdiction.
