

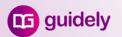

Bank of Baroda becomes one of the first public sector banks to launch a crèche/child day care facility for children of its employees. The initiative is designed to help employees save time and reduce the stress of finding the right care for children in the age group of 6 months to 6 years.

# 2) Answer: d)

Canara Bank is the first public sector bank to shift to EMV chip and PIN for card present transactions across the country's vast ATM network.

It is aimed at reducing lost and stolen card fraud and making counterfeit card fraud more difficult.



The Reserve Bank of India (RBI) had set a deadline of December 31, 2018 for the switch, mandating the use of an embedded chip to replace the traditional magnetic stripe card.

Fiscal Responsibility and Budget Management (FRBM) Act, 2003. FRBM Act set targets for the government to reduce fiscal deficits. As per the FRBM act, The Union budget for the current financial year proposes to bring down fiscal deficit to 3.3 percent, 3.1 percent and 3 percent of the gross domestic product by 2018-19, 2019-20 and 2020-21, respectively.

### 4) Answer: a)


Non-Residential Ordinary or NRO Account is generally opened in India as a normal bank account by an Indian national before leaving the country to work abroad.

It refers to funds deposited with an Indian financial institution opened by an Indian national with the intention of becoming a Non-Resident Indian or NRI.

The foreign currency which deposited to the NRO account is automatically converted to INR.

#### 5) Answer: b)

The Global Risks Report is an annual study published by the World Economic Forum in partnership with Marsh & McLennan Companies and Zurich Insurance Group. The report describes changes occurring in the global risks landscape from year to year. The report's findings are based on the annual Global Risks Perception Survey, which asks the Forum's network of business, government, civil society and thought leaders to gauge the risks facing our world.

Started in 1961, the award carries a cash prize of ₹ 500,000, a bronze statue of Arjuna and a scroll.

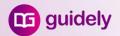
#### 8) Answer: a)
