



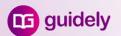
Answers :

The Ombudsman scheme was launched under Section 18 of the Payment and Settlement Systems Act, 2007. It would provide a cost-free and expeditious complaint redressal mechanism related to a deficiency in customer services in digital transactions conducted through non-banking entities regulated by the RBI. The offices of Ombudsman for Digital Transactions (ODT) would function from the existing 21 offices of the Banking Ombudsman.

NEFT system facilitates one-way cross-border transfer of funds from India to Nepal under the Indo-Nepal Remittance Facility Scheme; a remitter can transfer funds from any of the NEFT-enabled branches in India to Nepal, where the beneficiary would receive funds in Nepalese Rupees.

Under PPF Scheme one has to deposit before the 5th of the month to get interest for the full month as the interest is allowed on the lowest balance at the credit of an account from the close of the 5th day and the end of the month. Many investors deposit a lump sum amount right at the beginning of the financial year. Current incomes like rent, dividend, pension, interest etc. are also construed as a permissible credit to the NRE account.
