
1) Answer: e)

E-Stamps have been introduced in India in order to help the general public access stamps from the government in an easy and accessible way without much hassle. This service is very much cost effective for both the government and the user and at the same, accessibility of stamps has also increased because of the introduction of e-stamps

Mobile Money Identifier has 7 digits in it and it is used for customers to transfer funds from one account to another. It should be combined with the mobile number in order to facilitate fund transfer and that is where the security aspect of the transaction lies. Different MMIDs may have been linked with the same mobile number

ATMs set up, owned and operated by non-banks are called White Label ATMs. ATMs provided for Agricultural Transactions are called Green Label ATMs. ATMs provided for Share Transactions are called Orange Label ATMs. ATMs used for Women Banking are called Pink Label ATMs.

Residuary Non-Banking companies are such organizations which can be engaged in accepting deposits from the public only and under any circumstances, these companies cannot enter the business of asset financing, hire and purchase etc. The maximum period of deposits with these organizations can be 84 months whereas the minimum is 12 months

Non-Banking Finance Companies can be classified into a number of organizations and they are loan companies i.e. the companies which are mainly engaged in the business of lease and purchase, infrastructure finance companies, asset finance companies, residuary non-banking companies etc
