



1) Answer: c)

The Reserve Bank's affairs are governed by a central board of directors. The board is appointed by the Government of India in keeping with the Reserve Bank of India Act.

- Appointed/nominated for a period of four years
- Constitution:

Official Directors

Full-time: Governor and not more than four Deputy Governors

Non-Official Directors

Nominated by Government: ten Directors from various fields and two government Official

Others: four Directors - one each from four local boards

2) Answer: e)

According to 'Section 5 (B) of Banking Regulations Act, 1949', the banking means accepting deposits for the purpose of lending and investment. Deposits are lifelines of banks.

Such deposits are either demand or time deposits. Demand deposits are made up of current accounts and saving accounts, while time deposits include FDR, short-term deposits, recurring deposits etc.



3) Answer: b)

'Negotiated Dealing System (NDS)' is an electronic trading platform operated by the Reserve Bank of India to facilitate the issuing and exchange of government securities and other types of money market instruments.

The goal was to reduce inefficiencies stemming from telephone orders and manual paperwork while increasing transparency for all market participants. It was introduced in 2002.

The Basel Committee's revised framework is based on the following three pillars,

- First Pillar- Minimum Capital Requirement
- Second Pillar- Supervisory Review Process
- Third Pillar- Market Discipline

5) Answer: b)

'Domestic-Systematically Important Bank (D-SIB)' means that the bank is too big to fail.

According to the RBI, some banks become systemically important due to their size, crossjurisdictional activities, complexity and lack of substitute and interconnection. Banks whose assets exceed 2% of GDP are considered part of this group.

The RBI stated that should such a bank fail, there would be significant disruption to the essential services they provide to the banking system and the overall economy.

6) Answer: b)

Fernando Torres is a famous Spanish football player.

He is a Spanish international and made his debut against Portugal in 2003.

He is his country's third-highest goal-scorer of all-time.

Spain won the three tournaments from 2008 to 2012, with Torres scoring in the finals of both Euro 2008 and Euro 2012.


